It is notified that pursuant to the decision of Hon'ble High Court dated 18.09.2012 passed in a PIL/CWP no. 20056 of 2009, the inspection committee which inspected your college to check the compliance of previous conditions/shortcomings pointed out by the previous inspection committee, all the conditions mentioned in the previous continuation in provisional affiliation letter and to verify the required infrastructural facilities, teaching faculty, other supporting staff and other amenities required to run the existing B.Ed course as per norms and standards prescribed by the University in the revised quantified inspection proforma to consider the matter of re-categorization of concerned college to be placed in category 'A', 'B' or 'C' (on the basis of available facilities/faculty/ other support systems) and to consider the matter of grant of continuation in provisional affiliation for the session 2013-14 has submitted its report

The report of the inspection committees were scrutinized by the screening committees constituted by the Vice-Chancellor in order to maintain a uniformity in deciding the re-categorization of colleges of Education and the screening committees after scrutinizing the reports and record available with University has submitted its reports on a summary performa devised for the purpose as well as its recommendations. The recommendation of the screening committees has been considered by the Vice-Chancellor and has been pleased to grant conditional continuation in provisional affiliation to the following colleges of Education affiliated with this University for the session 2013-14 for running B.Ed./M.Ed. regular courses with existing intake, as per detail given below :-

If the same has not yet been submitted with the University.

Therefore you are asked to complete the deficiencies / shortcomings / conditions mentioned in the summary performa and send compliance for the same with in above stipulated period for necessary verification. On receipt of compliance report the University will get the compliance verified through an Inspection Committee of the University. If any college fails to submit the compliance report of shortcoming / deficiencies / conditions with in above stipulated period suitable action will be recommended to the NCTE against such college and in that case

the continuation affiliation for B Ed. course for the next the session i.e. 2014-15 shall not be allowed and disciplinary proceeding for withdrawal of provisional affiliation shall be initiated.
