Sub: Categorization of College and matter regarding continuation in provisional affiliation for the existing B.Ed course with existing intake for the session 2009-10 and 2010-11

Sir,

It is stated that the inspection committee which inspected your college to verify the required infrastructural facilities, teaching faculty and other amenities required to run the existing B.Ed course as per norms and standards prescribed in the quantified inspection proforma to consider the matter of categorization of concerned college to be placed in category 'A', 'B' and 'C' (on the basis of available facilities/faculty) and the matter of grant of continuation in provisional affiliation for the session 2009-10 and 2010-11 has submitted the report. A screening committee was constituted to further scrutinize each of the inspection report and assess the availability of teaching faculty according to the prescribed qualification of the University and as per new rules. The Screening Committee scrutinized of the documents submitted to the inspection committee at the time of inspection and found that your college is deficient in regard to the teaching faculty as under:-

Lecturers=4 (this is against the requirement of 1 principal, 7 lecturers being intake of 100 seats of B.Ed course of your College)

In addition to above, the inspection committee in its report has also pointed out deficiencies/shortcomings in your college on other two aspects i.e. Infrastructure and amenities as per detail given in the report(copy enclosed).

After scrutiny of the inspection report and keeping in view the number of qualified existing staff and available infrastructural facilities the Screening Committee has recommended to place your college in Category 'B'. The report/recommendations of the screening committee has been considered by the Vice-Chancellor who while allowing the continuation in provisional affiliation (in view of the reason that the session 2009-10 and has already been over and the session 2010-11 is in the mid way) for the session 2009-10 and 2010-11, has ordered to ask the colleges to fulfill the deficient requirement of teaching faculty and shortcomings/deficiencies pointed out in the inspection report of the inspection committee. Accordingly, I have been directed to convey as under:-


1. Continuation in provisional affiliation for running B.Ed course with existing intake for the session 2009-10 and 2010-11.
2. To appoint the deficient teaching faculty according to the prescribed qualification/procedure of the University as per new rules circulated vide letter No. CB-III/10/108-401 dated 3.1.2010 (a copy of which can also be taken from the University Website www.mdurohtak.com) and also to seek University approval of appointment of above deficient teaching faculty.

3. To seek the University approval in respect of the teaching faculty working in your college for which no such approval has so far been obtained by your college from the University and also even for those principal/lecturers whose approval have already been communicated by the University.
4. To complete the deficiencies/shortcomings pointed out by the inspection committee in its report

I have further been directed to ask you to complete the above deficiencies /shortcomings and send compliance of the same to the University within a period of three month for necessary verification. On receipt of compliance report the University will get the compliance verified through an inspection committee of the University. After verification of the compliance, if your college is still found deficient suitable action will be recommended to the NCTE against your college and in that case the continuation in affiliation for B.Ed course for the next session i.e. 2011-12 shall not be allowed by the University till the completion of above deficiencies/shortcomings. Any violation in submission of compliance with the above prescribed period shall amount to violation of the University instructions and your college shall be inviting itself for disciplinary action in terms of Act, Statutes and ordinances of the University.
